

Wahlburgers Passport Promotion Official Rules

1. All individuals must be eighteen (18) years of age or older and a legal resident of the 50 United States (and the District of Columbia) to participate in the Wahlburgers Passport promotion. Void in all other jurisdictions and where prohibited by law.
2. Employees, contractors, directors, agents and officers of Wahlburgers Pittsburgh, and members of the immediate family (spouse, parent, child, sibling, and their respective spouses) and household members of each such employee are not eligible to participate.
3. By participating, entrants agree to these official rules and the decisions of Wahlburgers Pittsburgh, which are final and binding in all matters relating to this promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein.
4. The promotion begins on Jan 29, 2018 and ends on Feb 26, 2018. On Feb 28, 2018 at 5pm, Wahlburgers Pittsburgh will randomly select one (1) winner from all among all eligible entries received during the promotion period. An entrant is not a winner of any prize, even if the drawing should so indicate, unless and until entrant's eligibility and compliance with the official rules have been verified and entrant has been notified that verification is complete. The potential winner will be notified by either email or phone using the information provided during entry into promotion. If a potential winner cannot be reached (regardless of reason), or is disqualified for any reason, the potential winner will forfeit the prize and Wahlburgers will award the prize to an alternate winner selected at random from the remaining entries. Upon disqualification, no further compensation will be given. Failure to comply with any term or condition in these rules may result in disqualification at Wahlburgers Pittsburgh sole discretion. Odds of winning will depend upon the total number of entries received.
5. Entries may be earned in three ways, with one winner from each method qualifying for the Grand Prize.
 - a. Facebook (no purchase required, one entry per person) – Entrants must go to the Wahlburgers Pittsburgh Facebook page, then 1) Follow the Wahlburgers page, 2) Like the post announcing this promotion, 3) Share that post on their own page, and 4) Comment on the Wahlburgers Pittsburgh post.
 - b. Twitter (no purchase required, one entry per person) - Entrants must post a picture of themselves with their favorite entrée from Wahlburgers while including the #Wahlspenspassport hashtag.
 - c. Entry in restaurant (purchase required, one entry per person) – Entrants will find on their receipt a link they can follow to fill in their name, email and phone number. All eligible entries will be placed into the drawing.
6. On Feb 28, 2018 at 5pm, Wahlburgers Pittsburgh will select one name from each entry method for a total of three (3) finalists. Each of the three finalists will then be randomly selected to win one of the following prizes.
 - a. One (1) Grand Prize winner will receive the following prize(s) – Wahlburgers gift card in the amount of \$1400 (That works out to two Our Burgers, Fries or Tots, and 2 drinks once a week for an entire year!) The Grand Prize winner will also qualify for the Penguins Passport Grand Prize drawing that will take place on or about March 2, 2018.
 - b. One (1) winner will receive a signed Penguins jersey and a Wahlburgers merchandise package
 - c. One (1) winner will receive two (2) tickets to 2018 Penguins season opener, a commemorative Penguins art piece from a local artist and a Wahlburgers merchandise package.
7. Acceptance of prize constitutes permission to Wahlburgers and its agents to use the winner's name and/or likenesses, prize information, photograph, voice, and comments for purposes of advertising and trade without further notice, permission, or compensation, unless prohibited by law.

The Released Parties are not responsible for: (1) any incorrect or inaccurate information, printing errors or by any of the equipment or programming associated with or utilized in the Event; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Event; (4) technical or human error which may occur in the administration of the Event; (5) lost, late, illegible, misdirected, mutilated, or incomplete submissions

If, for any reason, the promotion is not capable of running as planned, Wahlburgers Pittsburgh may, in its sole discretion, void any suspect entries and cancel or terminate the promotion; modify or suspend the promotion to address the impairment and then resume the promotion in a manner that best conforms to the spirit of these official rules; and/or award the prize in accordance with the winner selection criteria set forth above from among all eligible, non-suspect entries received. Wahlburgers Pittsburgh reserves the right, in its sole discretion, to disqualify any

individual it finds to be tampering with the entry process or the operation of the promotion or to be acting in violation of the official rules.

12. Management of Wahlburgers Pittsburgh will resolve any dispute or situation not covered by these Official Rules and that decision shall be final and binding.
13. If any of the preceding rules are found to be invalid, all other rules shall remain in effect.
14. All decisions made by Wahlburgers Pittsburgh management are final.
