

NY RANGERS “JEAN RATELLE NIGHT” SWEEPSTAKES (The “Sweepstakes”)

OFFICIAL RULES

**NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.
A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

1. **PERIOD:** Sweepstakes begins at 9:00 a.m. Eastern Time (“ET”) on February 21, 2018 and ends at 6:00 p.m. ET on February 25, 2018 (the “Sweepstakes Period”).

2. **ELIGIBILITY:** Sweepstakes is open to U.S. legal residents of the fifty (50) United States and/or District of Columbia, at least eighteen (18) years old at time of entry. Sweepstakes is void outside the area stated herein and where prohibited by law. Directors, employees, and the immediate family (spouse, parent, sibling, children, grandparent or grandchildren and their respective spouses, regardless of where they reside) and/or household members of individuals, whether or not related, employed by New York Rangers, LLC (the “Rangers” or “Sponsor”), MSG Sports & Entertainment, LLC (“MSG”), the National Hockey League and its member teams, NHL Enterprises, L.P. (collectively, “NHL Entities”), and all of their respective parents, subsidiaries, affiliates, directors, officers, employees, advertising and promotional agencies, are ineligible to participate. Sweepstakes is subject to all applicable federal, state and local laws.

3. **TO ENTER:** Limit one (1) entry per person, regardless of method of entry.

i) **Method #1:** Fans who are in attendance at the New York Rangers home games at the arena at Madison Square Garden (the “Arena”) on Sunday, February 25, 2018 will be automatically entered for a chance to win.

ii) **Method #2:** To enter without purchasing a ticket to the Rangers game, print your full name, date of birth, e-mail address, street address (including city, state and zip code) and day and evening telephone numbers on one side of a 3”x5” index card and mail it to: Rangers “Jean Ratelle Night” Sweepstakes, Two Pennsylvania Plaza, 14th Floor, New York, NY 10121.

Multiple entries from any person will be void. Any attempt to use multiple names or other tactics to enter more than the stated limit may result in entrant’s disqualification by Sponsor from the Sweepstakes, including all associated entries being voided. Entries generated by script, macro or other automated means or by any means which subvert the entry process are void. All entries become the property of Sponsor and will not be acknowledged or returned.

4. **SELECTION OF WINNERS:** Nineteen (19) potential winners will be selected at random from among all eligible entries received (each, a “Potential Winner”). Odds of winning depend on the total number of eligible entries received. Potential Winners will be notified by an attendee at the game (if winner entered via Entry Method #1) or by e-mail (if winner entered via Entry Method #2). If a Potential Winner does not respond and comply with the instructions within three (3) days after Sponsor sent the message, is not in his/her seat location after two (2) attempts, he/she will forfeit the prize and Sponsor may select an alternate Potential Winner in his/her place in a random drawing of all eligible entries received for the drawing at issue. The Potential Winner must comply with all terms and conditions of these Official Rules, and winning a prize is contingent upon fulfilling all requirements. A Potential Winner may be required to sign and return an Affidavit of Eligibility and Liability and, unless prohibited, Publicity Release within 24 hours of the date of notice in order to claim his/her prize and become an official

winner (“Official Winner”). If a prize or prize notification is returned as undelivered, a Potential Winner cannot be contacted, or fails to sign and return the Affidavit of Eligibility and Liability and Publicity Release within the required time period or is not in compliance with these Official Rules, the Potential Winner may be disqualified and forfeits the prize. Official Winners will be responsible for all federal, state and local taxes and fees and other costs and expenses associated with Prize receipt and/or use that are not expressly included in the Prize description. No cash or other substitution, assignment or transfer of any prize permitted, except by Sponsor, who reserves the right to substitute prize or prize component with cash or another prize of comparable or greater value. GENERAL CONDITIONS: Released Parties (as defined below) are not responsible for lost, late, incomplete, inaccurate, stolen, delayed, misdirected, undelivered or garbled entries or emails or postage-due, damaged or illegible mail; or for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), website, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the prizes, or in any Sweepstakes-related materials. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Sweepstakes. Sponsor reserves the right to cancel or modify the Sweepstakes if fraud, technical failures or any other factor impairs the integrity of the Sweepstakes, as determined by Sponsor in its sole discretion. In such event, Sponsor reserves the right to award the prize(s) at issue from among the non-suspect, eligible entries received for such drawing(s) up to the time of the impairment or as otherwise deemed fair and appropriate by Sponsor. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules, or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately

damage or undermine the legitimate operation of the Sweepstakes is a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages and other remedies (including, without limitation, attorney's fees) from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. In the event of a dispute regarding entries received from multiple users having the same e-mail account, the authorized subscriber of the e-mail account at the time of entry will be deemed to be the entrant and must comply with these rules. Authorized account subscriber is the natural person who is assigned the e-mail address by the Internet Service Provider (ISP), on-line service provider, or other organization responsible for assigning e-mail addresses.

9. **RELEASE/LIMITS OF LIABILITY:** By entering this Sweepstakes, each entrant and Official Winner agrees to release and hold harmless New York Rangers, LLC, MSG Sports & Entertainment, LLC, the NHL Entities, their respective parents, affiliates, subsidiaries, officers, directors, shareholders, agents, employees and all others associated with the development and execution of this Sweepstakes (collectively, "Released Parties") from and against any losses, damages, rights, claim or cause of action of any kind arising, in whole or in part, directly or indirectly, out of participation in the Sweepstakes or resulting directly or indirectly, from acceptance, possession, use, or misuse of any Prize awarded in connection with the Sweepstakes, including without limitation personal injury, death, and/or property damage, as well as claims based on publicity rights, defamation, and/or invasion of privacy.
