OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR OTHERWISE RESTRICTED BY LAW.

- 1. ELIGIBILITY:** The Pittsburgh Penguins “Enter to Win a PENGUINS PASSPORTSM with The Yard” Sweepstakes (the “Sweepstakes”) is open only to legal residents of Pennsylvania residing within seventy-five (75) miles of PPG Paints Arena in Pittsburgh, PA, who are at least 18 years of age at the time of entry. Void in all other jurisdictions and where prohibited by law. The potential winner will be notified by phone or email using the contact information provided during registration. All potential winners will be subject to verification of eligibility, and may be required to sign and return an Affidavit of Eligibility/Release of Liability/Prize Acceptance Form (“Release”) within five (5) days of the date notice or attempted notice is sent in order to claim the Prize.
